





Fig.3 DC Current Gain vs. Collector Current (I)





Fig.4 DC Current Gain vs. Collector Current (II)

Fig.5 Collector-Emitter Saturation Voltage vs. Collector Current(I)




Fig.6 Collector-Emitter Saturation Voltage vs. Collector Current(II)




Fig.7 Base-Emitter Saturation Voltage vs. Collector Current (I)





Fig.8 Gain Bandwith Product vs. Emitter Current

Fig.9 Collector Output Capacitance vs. Collector-Base Voltage Emitter Input Capacitance vs. **Emitter-Base Voltage**




Fig.10 Safe Operating Area




Fig.11 Safe Operating Area





Fig.12 Safe Operating Area

Fig.13 Safe Operating Area




Fig.14 Safe Operating Area






Fig.15 Safe Operating Area








